In the event AllStar Bass, et al is sued because of my actions, I expressly agree to indemnify and hold AllStar Bass, et al harmless from any liability whatsoever, including court costs and attorney's fees, arising with respect to such actions. I understand that in waiving my rights to sue AllStar Bass, et al, I am also waiving the rights of recovery from AllStar Bass, et al of my insurance carrier for any claims that they may pay on my behalf.

3. **VERIFICATION OF LIABILITY INSURANCE.** I further state that I am a current member of AllStar Bass Fishing Tournaments, and that I maintain liability insurance on the boat I will be using in this tournament.
