AllStar Bass Fishing Tournaments, Inc., as used herein the term “events” shall mean team tournaments to be held on various published dates from October 7 2006, through September 9, 2007. In consideration of being permitted to enter for any purposes any RESTRICTED AREA (herein defined as including but not limited to the area where any activity related to fishing or event activities shall take place), or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in the event, each of the undersigned, for himself or herself, his or her personal representatives that he has, or will immediately on entering any of such Restricted areas, and will continuously thereafter inspect such Restricted areas and all portions thereof which he enter and with which comes in contact, and does further warrant that entry on such Restricted area or areas and participation, if any, in the event constitutes an acknowledgment that he has inspected such Restricted area and that he finds and accepts the same as being safe and reasonably suited for the purposes of its use. He further agrees and warrants that if any time, he is in or about Restricted areas and he feels anything to be unsafe, he will immediately advise the proper officials and will leave the Restricted areas. Further the undersigned hereby:

1. Releases, waives, discharges and covenants not to sue AllStar Bass Fishing Tournaments, the promoters, participants, fishing association, sanctioning organizations or any subdivision thereof, any persons in any Restricted areas, sponsors, advertisers, owner and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as “releasees”, from all liability to the undersigned, personal representatives, assign’s, heirs and next of kind for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned or the undersigned’s child, whether caused by the releasees or otherwise while the undersigned or his or her child is in or upon Restricted areas, and/or competing, officiating in, observing, working for, or for any purpose participating in the event.

2. Agrees to indemnify and save and hold harmless the releasees and each of them from any loss, liability, damage, or cost they might incur due to the presence of the undersigned or the undersigned's child, in or on the restricted area or in any way competing, officiating, observing, or working for or for any purpose participating in an event and whether caused by the negligence of the releases or otherwise.

3. Assumes full responsibility for and risk of bodily injury, death or property damage to himself, herself or his or her child due to the negligence of releasees or otherwise while in or on a Restricted area and or while competing, officiating, observing, or working for or for any purpose participating in an event. Each of the undersigned expressly acknowledges and agrees that the activities of the event may be dangerous and involve the risk of serious injury and/or death and/or property damage and which responsibility for such risks are hereby voluntarily assumed. Each of the undersigned further expressly agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State of Arizona, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. This release is intended to discharge and shall in advance releasees from and against any and all liability arising out of or in connection in any way with the participation of the undersigned or the undersigned's child heretofore named in the event even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above.

4. Understands that AllStar Bass Fishing tournaments is conducting tournaments on public bodies of water. AllStar Bass does not exercise any control over marine safety, watercraft operation, coast guard, state or local rules or regulations. Each participant and lake user is required to obey all applicable laws, rules and guidelines for safe use of and activities on the water and at all facilities.

The undersigned has read and voluntarily signs the release and waiver of liability and indemnity agreement, and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement have been made.
